Background of the Project

The ONS has embarked on a program of 'statistical archaeology' projects to make more historical census outputs available to the public in digital form. The coming years will see the digitisation of census outputs from 1921 through to 1961. This data represents digitised versions of tables from the 1921 Census County Reports and Topic Reports. The tables available are the first of several batches of releases. More data will be added as it becomes available.

These data were never published digitally and until now have been available as scanned images of the printed 1921 Census tables. This project aimed to breathe new life into the data by retrieving and processing content from the 1921 Census County and Topic Reports. The digitisation of the data was performed by the University of Salford's Pattern Recognition and Image Analysis (PRImA) Research Lab.

With the data digitised, the ONS plans to make it available to the public and researchers via the Nomis website.

An important note: there is no attempt being made to update or modernise the language or terminology published as part of the program of historical record digitisation. Rather, the information will be presented, both within the datasets and the surrounding meta-data, as printed at the time wherever possible. There may be some instances in which additional information is given to provide clarity.

These tables are presented in a format which has been designed to be the most accessible and usable to a modern audience. As such they may not be in the same format as originally printed and the presentation will differ from the tables seen in the original county and topic reports. A number of the tables are currently available only as a data download file. Where possible, these will be made available in tabular format in later releases.

Quality Assurance of the Data

During processing, errors were identified in the original printed versions. Where possible these have been corrected. As such some of the figures may be different to the original printed versions.

1921 Census Methodology

Basis of enumeration

The 1921 Census was undertaken on Sunday 19th June 1921. The 1921 Census statistics include the living population enumerated at midnight, 19/20th June, 1921. For each area the population is those present on Census night as permanent residents or temporary visitors. Those working or travelling during the night were

included at the place where they arrived on the following day. This includes persons on board vessels in port on Census night or who arrived there on the following day. Fishermen, etc., at sea on Census night who did not arrive in port the following morning are not included in the population.

Census date

This population will never match the permanently resident population, but the Census date of March or April was originally chosen for minimal movement of the population. The 1921 Census was postponed to 19th June from 24th April due to the coal dispute and expectation of a strike of railwaymen and transport workers. This was the latest date before the start of a series of public and industrial holidays that would continue into the Autumn. However, unusually fine weather at this time meant some movement due to holidays, with a higher than usual population in holiday resorts. An estimate of the increase in population due to temporary visitors in the most affected districts was described in the General Tables Appendix A and an image is available in Appendix A of this User Guide.

Enumeration

Similar to previous censuses the country was divided by the local Registrars of Births and Deaths into 38,563 enumeration districts and for each district an Enumerator delivered and collected census schedules. H.M. Customs and Excise officers enumerated persons on board mercantile shipping, fishing vessels, etc.; the Corporation of Trinity House arranged enumeration for persons on lighthouses and lightships; and the police were responsible for enumerating the homeless. For the first time, respondents could fill in an individual form to keep details private from the rest of the household. The Census Office provided census schedules to the Isle of Man and Channel Islands and the census was carried out on the same date by the Island Governments. On the same day a census of overseas armed forces establishments was taken. Due to the Irish War of Independence, the census did not take place in Ireland. Local officers checked schedules and enumeration books and would frequently raise queries with the person making the return.

Questions Asked and Questionnaires

Due to limited space on the Census schedule questions were selected which would best meet present and future user needs, and for the first-time questions which had previously been asked (fertility and infirmity) were not included. The fertility question used in the 1911 Census (length of existing marriages and the number of children born in the marriage) had given long range data which was still of use, while data on infirmities was felt to be unreliable. The age question was changed to ask for age in years and months to increase response accuracy. The question on education was revised to show demand for education facilities, although the postponement of the census until the summer term meant that evening and other special courses were less likely to be running. New questions on dependency and orphanhood helped to prepare the financial framework of the Widows', Orphans' and Old Age Contributory Pensions Act, 1925. The 1921 Census was the first time that all employees were asked for the name of their employer and their workplace address.

Consistency with Later Censuses

Just as outlined above the 1921 Census included new questions and topics that were not asked about in the previous census, so too have additional questions been asked in the censuses that have been conducted since. The ONS website contains a document¹ outlining all census topics covered from the first census in 1801, through to the 2011 Census. To give a few examples, 1921 did not ask questions related to the number of cars or vans within a household, ethnic group, or religion.

Geography

The data relates to the 1921 County Reports and Topic Reports for England and Wales. The data is available on Nomis down to 1921 district level although not all tables are available at the most detailed level of geography (see Tables section below for area type available for each table). Lower levels of geography will be included in subsequent releases.

1921 local authority and higher digital boundaries are available on the <u>Open</u> <u>Geography Portal</u>.

Districts

For 1921 district names, there are suffixed acronyms which give further detail about the nature of the district. These are detailed below:

When downloading data from Nomis, where districts in different geographical locations have the same name, the name of the administrative county has been included in brackets after the district name. This is to aid users in being able to correctly identify the district selected.

For some tables the districts included may be limited to Urban or Rural Districts over a certain population size (usually 50,000 or 20,000), along with County Boroughs

and Metropolitan Boroughs. A corresponding table with less detailed variable classifications includes Urban and Rural Districts with populations under that size.

Ancient Counties

Some tables in the 1921 reports give data for ancient counties. For dissemination on Nomis, the decision was made to present data at administrative county (with associated county borough where applicable) level only. This allows for more detailed information to be given, and for consistency of geography across tables. The following seven ancient counties are comprised of the following administrative counties, for all other counties, the ancient and administrative versions comprise the same geographical area:

Monmouthshire

According to the list of counties included within the regions of England of Wales listed in Table VII of the General Report, Monmouthshire is classed as a Welsh

county. To that end, the data provided for regions includes Monmouthshire within the "Welsh counties".

However, for the purposes of the 1921 Census outputs, Monmouthshire was generally included within England. In some of the printed tables, figures were given for both "England including Monmouthshire" and "England excluding Monmouthshire", likewise for Wales. These additional breakdowns are not being included within the digitised data at this time and for the purposes of dissemination on Nomis, Monmouthshire has been included within England only to align with the majority of printed tables. As such, any user aggregated data from regions to country will not match figures given for England and for Wales on Nomis.

Definitions

The following definitions have been taken from the 1921 County Reports. They are for England and Wales.

Private family

"Any person or group of persons included in a separate return as being in separate occupation of any premises or part of premises is treated as a separate family for Census purposes, lodgers being so treated only when returned as boarding separately and not otherwise. Private families comprise all such families with the exception of those enumerated in (i) Institutions or (ii) business establishments or boarding houses in which the number of resident trade assistants or resident boarders exceeds the number of members of the employer's or householder's family (including private domestic servants)."

Rooms

"For the purpose of the Census the rooms enumerated are the usual living rooms, including bedrooms and kitchens but excluding sculleries, landings, lobbies, closets, bathrooms, or any warehouse, office or shop rooms."

Structurally separate dwellings

"A structurally separate dwelling has been defined for the Census as any room or set of rooms, intended or used for habitation, having separate access either to the street or to a common landing or staircase. Thus, each flat in a block of flats is a separate unit; a private house which has not been structurally subdivided is similarly a single unit whether occupied by one family or by several families. But where a private house has been subdivided into maisonettes or portions, each having its front door opening on to the street or on to a common landing or staircase to which visitors have access, then each such portion is treated as a separate unit.

Where an undivided private house is used partly for business or professional purposes, it is treated as occupied by a private family unless the portion used for non-domestic purposes consists of at least 3 rooms and is more than one quarter of the whole."

The following definitions were not available in the 1921 County Reports but have been provided. They are for England and Wales.

Inmates

Inmates comprise those persons in an institution for treatment, care, or detention, etc. as appropriate for the class of institution.

Overcrowding

The 1921 definition of overcrowding was where there were more than two persons per room, although it should be noted that the 1921 Census data gives rooms per person and as such can't be used as evidence of 'overcrowding' as defined.

Description of Table

Shows population by sex and population density, the number of private families and the population therein, and a count of structurally separate dwellings occupied by private families, including the number of rooms occupied and number of rooms per person. This table also includes a population count from 1911 for comparison.

Additional Information

The dwellings shown are those occupied by private families only.

There are also a number of other footnotes giving information specific to particular areas.

The footnotes specific to areas have not yet been digitised.

Description of Table

Shows private families by the size of family and rooms occupied, the population in private families, and the density of occupation, including average number of rooms per person. The table also includes a comparison with 1911 of the percentage of families living within the specified number of rooms.

Additional Information

There is a version of the table for administrative counties which has single number of rooms categories for six to 15 or more rooms.

A header note is included with the table:

The following table contains an analysis of the private families within each area according to

- (a) the number of persons in the family, and
- (b) the number of rooms occupied by the family.

Where more than one family is enumerated within a structurally separate dwelling, each is classified according to the rooms it severally occupies and not to the total number of rooms in the dwelling. If, as occasionally happens, one of the rooms is shared by two families (the allotment to each family being say $4\frac{1}{2}$ and $3\frac{1}{2}$ in an 8-roomed dwelling) the families are classified to the next higher integral number of rooms (5 and 4 respectively) but in arriving at the totals (column (m) etc.) the actual figures ($4\frac{1}{2}$ and $3\frac{1}{2}$) have been used."

Additional Information

The original title for this table was "Institutions: Number, total population and inmates of certain classes of institutions and other special premises". For presentation on Nomis the title has been shortened.

The differentiation of total population and inmates applies only to institution classes 1-13 (see <u>Classifications</u> section for details).

For Workhouses, Separate Poor Law Institutions for Sick, and Other Poor Law Institutions (classes 1-3) the administering board of guardians is disaggregated on the printed tables. However, the data has been aggregated for dissemination on Nomis, giving an overall figure for the district in question. As such, the counts for the individual administrating board of guardians are not currently available in the digitised data.

There are a number of footnotes giving information specific to particular areas which have not yet been digitised.

In the printed County Reports, the county level data presented for Table 12 was given for ancient counties. For dissemination of data on Nomis, the decision was made to simplify the county geographies and only present data for all tables for administrative counties (with associated county borough where applicable). Doing so allows continuity of geography across the tables and gives the data at a more granular level than would be available in the ancient counties.
